The processed data are required for an active participation (as audience but also for participation in the discussion following the presentation). **Recordings of lectures and/or the following discussions or parts of the lectures/discussions are prohibited** – registration is neither allowed for the organizer or lecturer nor for participants.

In our Research Colloquium we use the video conference tool Zoom. 6. Consequences of not providing data

7. Using cookies

When you visit a page, the browser will save a so-called "session cookie" to the end device in use after a one-time log-in to protected areas. The cookie will be deleted as soon as the browser is closed. The purpose here is to recognize multiple related requests from the same user, which preserves the user's log-in status while using the website. Blocking these cookies can impair access to and use of the website.

The University of Konstanz uses the web conferencing service Zoom for its teaching, research and self-administration activities. This service is used for online courses, exams and meetings (hereafter: "online events") in situations where in-person events are not possible or not recommended. We process your personal data (hereafter "data") in line with legal requirements in a transparent manner. This is why we explain in this data protection information: which data we process in the context of Zoom, for what purpose we need to do so and what the legal basis is. We also provide you with information about contact persons and your rights.

III. Extent and purpose of data processing

If you take part in an online event at the University of Konstanz via Zoom, the data you enter during log in will be shared with Zoom. The amount of additional data processed depends on the data you enter before / during the online event.

If you have a business account with Zoom, the following data will be shared with Zoom after registration is complete (log in and confirmation):

- full name (displayed) as well as first and last names in separate fields,
- language settings,
- department,
- work email address,
- institution name "University of Konstanz".

The extent of data processed by Zoom depends on the group a person belongs to. The groups include Zoom users (user profile, metadata, recordings, content data and call data), persons mentioned during communication (recordings and content data) and staff members in Financial Affairs and the Communication, Information, Media Centre (KIM) (contract data):

metadata recordings	meeting metadata: topic and length of the meeting, start and end of participation (times), description of meetings (optional), chat status, participants' IP addresses, Mac addresses and other device IDs if applicable, approximate location for the purpose of connecting with the closest computing centre, device/hardware information like device type, operating system and version, client version, type of camera, microphone or loudspeaker, type of connection, etc. meeting recordings: mp4 files of all video and audio recordings and presentations, M4A files of all recordings, text file of all files used in meetings, chats histories and audio recordings and other information shared via Zoom Users are <u>informed here</u> directly that the online event may be recorded.
content data	chat histories
call data	call history (optional) if applicable: caller's phone number, country, IP address, emergency contact number, start and end time, host name, host email address, Mac address of the device used
contract data	invoices and purchasing data

The data processing serves the purpose of enabling online communication via web conferencing.

IV. Legal basis for data processing

We use Zoom services in teaching and general administrative activities. The legal basis for processing personal data depends on the area where it takes place.

We process the data of students, other members of the university and other persons who are taking part in courses and meetings. Data processing is required for performing the task in the public interest. In the area of teaching, the legal basis is provided by Article 6 para.1 sentence 1 lit. e, para. 3 GDPR in connection with § 4 Landesdatenschutzgesetz LDSG (state data protection act) and §§ 2, 12 Landeshochschulgesetz LHG (state law on higher education).

We also process the data of staff members as required for them to fulfil their work responsibilities. The legal basis is Article 88 para. 1 GDPR in connection with § 15 para. 1

LDSG and §§ 83 ff. Landesbeamtengesetz BW (state civil service act), as data processing is required for performing the task in the context of the employment relationship.

Data can also be processed in the context of a contract, for example in videoconferences as part of calls for tender, contract negotiations or the fulfilment of contracts, Article 6 para. 1 sentence 1 lit. b GDPR.

V. Storage duration

Even if you do not exercise the rights mentioned below, your data will only be stored as long as required to fulfil the purposes mentioned above. This does not apply if, contrary to this, a longer storage time is mandated by law or is required for legal enforcement within statutory periods of limitation. Even if data is only stored for the aforementioned purposes, the use of such data is limited to the minimum amount required.

If, in exceptional cases, an online event is recorded, the data from the audio and video stream as well as all messages sent via the chat, question or survey functions will be saved and kept afterwards for the period of time announced before the recording began.

VI. Recipients

Internal recipients are those staff members who need the data to complete their work responsibilities. Other recipients can exist in cases where we are legally required to share data.
